With over 18 years of experience in Information Technology, Aseem possesses valuable expertise in managing teams and successfully delivering major system development projects.

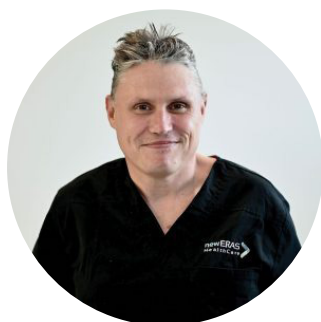

Dental Surgery (Sleep Dentistry) Including Open Access

- Dental Implants including grafts and sinus augmentation under anaesthesia.
- Tooth extraction under anaesthesia including wisdom teeth.
- Endodontic treatment including post and core under anaesthesia.
- Periodontic treatment under anaesthesia.
- Tooth fillings including fissure seals under anaesthesia.
- Crown/veneer inlays/inlays/bridges preparation under anaesthesia.
- Biopsy of lesions/cysts under anaesthesia.
- Removal of calculus/cleans under anaesthesia.
- Soft tissue surgeries gingivectomy/frenectomy under anaesthesia.
- Dental fractures under anaesthesia.
- Surgical exposure of unerupted teeth under anaesthesia.
- Splinting of displaced teeth under anaesthesia.
- Dentures under anaesthesia.



Minor General Procedures

- Excision of skin lesions.
- Excision or subcutaneous lesions e.g. Lipoma.
- Ligation, stripping, avulsion, injection of varicose veins (one leg at a time).
- Carpal tunnel decompression (Dupuytren contracture release).
- Umbilical hernia repair.
- Open repair of inguinal or femoral hernia.
- Excision of anal tags.
- Anorectal examination under anaesthesia.
- Injection and banding of haemorrhoids.
- Botox injection for anal fissure.
- Lateral sphincterotomy.
- Excision of scrotal lesions including epididymal cysts and open correction of hydrocoele and varicocele.
